The Compliance Report with requisite processing fee is required to be submitted every year by 31st August irrespective of the period of approval.

The above approval is subject to rectification of the following observations / deficiencies / specific conditions by 31st August, 2009.

Faculty

- Senior faculty in cadre ratio asper AICTE norms should be appointed.
- AICTE Pay scales should be implemented
- Faculty in the Humanities & Science should be appointed in the ratio of 1:15 for the incoming batch of students.

Built-up Area:

There is a shortfall of 316 sq.mt.in the builtup area as only 19205 sq.mt. is available against a requirement of 19521 sq.mt. (Deficiency-2%).

Computer Facility:

There is a shortfall of 326 sq.mt.in the instructional area as only 9574 sq.mt. is available against a requirement of 9900 sq.mt. (Deficiency-3%).

Library Facility:

 Library facilities in terms of titles, volumes and journals should be made available as per AICTE norms.

Others

- Internet facilities needs improvement.
- Placement cell needs improvement.
 - The deficiencies communicated in the last approval letter are not fully complied with.

Note: The mandatory disclosure in prescribed format is required to be hosted on the website as per directions in the AICTE website failing which, action would be initiated as per the rules and regulations of the AICTE including No

The institution is required to submit two copies of the Compliance Report, indicating the rectification of deficiencies along with mandatory disclosure and details of faculty recruited for each course in the prescribed format (available at AICTE Website www.aicte.ernet.in) to the concerned Regional Office latest by 31" August 2009 for consideration of approval beyond the session 2009-10. It may be noted that all the institutions are required to submit the Compliance Report alongwith requisite processing fee by 31st August every year irrespective of the period of approval.

The Compliance Report must be accompanied with a processing fee of Rs. 50,000/- in the form of demand draft in the favour of Member Secretary, AICTE, payable at New Delhi. In the absence of processing fee the Compliance Report will not be entertained. Following the Compliance report, the Council would verify the status in respect of rectification of deficiencies through surprise random inspection

The above approval if granted after rectification of deficiencies would be subject to the fulfillment of the following general

- That the management shall provide adequate funds for development of land and for providing related infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting
- That the admission shall be made only after adequate infrastructure and all other facilities are provided as per 2. (a)
 - That the admissions shall be made in accordance with the regulations notified by the Council from time to time. (b)
 - That the curriculum of the course, the procedure for evaluation/ assessment of students shall be in accordance (c)
 - That the Institution shall not allow closure of the Institution or discontinuation of the course(s) or start any new (d) course(s) or alter intake capacity of seats without the prior approval of the Council
 - That no excess admission shall be made by the Institution over and above the approved intake under any (e) circumstances. In case any excess admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
 - (f) That the institutions shall not have any collaborative arrangements with any Indian and/ or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of
 - That the Institution shall not conduct any course(s) in the field of technical education in the same premises/ (g) campus and / or in the name of the Institution without prior permission/ approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated
 - The institution shall not conduct any non-technical course(s) in the same premises/ campus under any (h) circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
- That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or in collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardians of students in any form.
